- Drivers provide “Door to Door” service. Drivers are not permitted to enter the passenger residence.
- Drivers may provide assistance with **package** delivery onto WCMTD vehicles and to the door of the residence only.
- When calling to make reservations please tell the dispatcher that you wish to make a reservation for the Senior Bus and give us your card number.
- Please call as far in advance as you can especially for out of town and rural passengers.
- Escorts/Assistants ride free with passenger when picked up and dropped off at the same address. Service animals are allowed on buses. Please let dispatcher know if you’re using any of these accommodations when you are making your reservations.
- Passengers traveling in wheelchairs or those needing vehicle lift assistance are required to be at ground level before drivers assist passengers onto the lift. Drivers will assist passengers on and off the vehicle.
- WCMTD vehicles are equipped with wheelchair lifts with a capacity of up to 1000 lbs.
- Drivers are not allowed to assist wheelchair passengers up or down steps or provide assistance to wheelchair passengers when hazardous conditions exist at the point of pick-up or at the point of destination.
- Drivers may not conduct matters of personal business for any passenger.
- WCMTD is **not responsible** for personal items or packages during transit, side stops, or when passenger exits the WCMTD vehicle.

WHY IS THERE A NEED FOR SENIOR TRANSPORTATION?

Transportation is the link that ensures older persons access to the services and opportunities that can reduce isolation and promote independent living.

HOW MUCH SHOULD I CONTRIBUTE?

Each person is asked to contribute whatever he or she can afford. A suggested donation statement will be mailed to each client at the end of the month. No eligible person will be denied transportation if they cannot contribute toward the cost of the ride. Your contributions keep the program in your community at its current level of service and quality.

SUGGESTED DONATIONS!

The suggested donation will be \$2.00 per unit of service provided within Brown County as well as trips to Rushville and Beardstown. The one way trip to Quincy and Jacksonville is \$5.00 (\$10.00 round trip).
